Why did Ambetter from WellCare of Kentucky implement a Medical Specialty Solutions Program?	Ambetter from WellCare of Kentucky implemented a Medical Specialty Solutions Program to ensure clinically appropriate care and manage the increasing utilization of non-emergent outpatient Medical Specialty Solutions services.
Why did Ambetter from WellCare of Kentucky select NIA to manage its Medical Specialty Solutions Program?	A subsidiary of Evolent Health, LLC, NIA was selected to partner with Ambetter from WellCare of Kentucky because of their clinically driven program designed to effectively manage quality and member safety, while ensuring appropriate utilization of resources for Ambetter from WellCare of Kentucky membership.
Which Ambetter from WellCare of Kentucky members are covered under this relationship and what networks are used?	NIA's Medical Specialty Solutions for Ambetter from WellCare of Kentucky membership is managed through Ambetter from WellCare of Kentucky contractual relationships.
PRIOR AUTHORIZATION	
What was the implementation date for the Medical Specialty Solutions Program?	Implementation was January 1, 2022.
What Medical Specialty Solutions Services require providers to obtain a prior authorization?	<ul> <li>The following non-emergent, outpatient, Medical Specialty Solutions services require prior authorization through NIA:</li> <li>MR, CT/CCTA, PET, Nuclear Cardiology/MPI, Stress Echo, Echocardiography</li> <li>Interventional Pain Management – Spine (Spinal Epidural Injections, Paravertebral Facet Joint Injections or Blocks, Paravertebral Facet Joint Denervation (Radiofrequency Neurolysis) *</li> </ul>

	<ul> <li>Physical Medicine Services (Physical, Occupational and Speech Therapy; Chiropractic Care) *</li> <li>*Please see the specific FAQ for each of the Medical Specialty Solutions Program Services.</li> <li>Emergency room, observation, and inpatient procedures do not require prior authorization from NIA. If an urgent/emergent clinical situation exists outside of a hospital emergency room, please contact NIA immediately with the appropriate clinical information for an expedited review.</li> </ul>
When is prior authorization required?	Prior authorization is required for outpatient, non- emergent procedures. Ordering providers must obtain prior authorization of these procedures prior to the service being performed at an imaging facility.
Is prior authorization necessary for sedation with an MRI?	No, prior authorization is not required for sedation when performed with an MRI.
Is an NIA authorization number needed for a CT- guided biopsy?	No, prior authorization is not required for this procedure.
Can a chiropractor order images?	Yes.
Are routine Imaging services a part of this program?	No.
Are inpatient Diagnostic Imaging (MR, CT/CCTA, PET) procedures included in this program?	No. Inpatient procedures are included in the authorization for the inpatient stay that is managed through the Ambetter from WellCare of Kentucky Medical Management Department.
Is prior authorization required for Medical Specialty Solutions Services performed in the emergency room?	No. Medical Specialty Solutions Services performed in the emergency room are not included in this program and do not require prior authorization through NIA.
How does the ordering provider obtain a prior authorization from NIA for a Medical Specialty Solutions outpatient service?	Providers are able to request prior authorization via the internet ( <u>www.RadMD.com</u> ) or by calling NIA at 1-800-424-9230.

What kind of response time can ordering providers expect for prior authorization?	Generally, within 2 business days after receipt of request with full clinical documentation, a determination will be made. In certain cases, the review process can take longer if additional clinical information is required to make a determination.
What does the NIA authorization number look like?	The NIA authorization number consists of alpha- numeric characters. In some cases, the ordering provider may receive an NIA tracking number (not the same as an authorization number) if the provider's authorization request is not approved at the time of initial contact. Providers can use either number to track the status of their request online or through an Interactive Voice Response (IVR) telephone system.
If requesting authorization through RadMD and the request pends, what happens next?	You will receive a tracking number and NIA will contact you to complete the process.
Can RadMD be used to request an expedited authorization request?	RadMD may only be used for expedited requests that occur after normal business hours. Those expedited requests that occur during normal business hours must be called into NIA's call center for review and processing.
What happens if a member is authorized for a service and the provider feels an additional study is needed?	If the provider feels that, in addition to the service already authorized, an additional service is needed, please contact NIA immediately with the appropriate clinical information for an expedited review. The number to call to obtain prior authorization is 1-800-424-9230.
Can the rendering facility obtain authorization in the event of an urgent service?	Yes. If they initiate the process, NIA will follow-up with the ordering provider to complete the process.
How long is the prior authorization number valid?	The authorization number is valid for 30 days from the date of request. When a procedure is authorized, NIA will use the date of the initial request as the starting point for the 30-day period in which the examination must be completed.

If a provider obtains a prior authorization number does that guarantee payment?	An authorization number is not a guarantee of payment. Authorizations are based on medical necessity and are contingent upon eligibility and benefits. Benefits may be subject to limitations and/or qualifications and will be determined when the claim is received for processing.
Does NIA allow retro- authorizations?	Yes. However, it is important that the rendering facility staff be educated on the prior authorization requirements. Claims will not be reimbursed if they have <u>not</u> been properly authorized. The rendering facility <b>should not</b> schedule services without prior authorization.
Can a provider verify an authorization number online?	Yes. Providers can check the status of member authorizations quickly and easily by going to the NIA website at <u>www.RadMD.com</u> .
Is the NIA authorization number displayed on the Ambetter from WellCare of Kentucky website?	No.
SCHEDULING SERVICES	
How does NIA determine where to schedule Medical Specialty Solutions Services for Ambetter from WellCare of Kentucky members?	NIA manages the Medical Specialty Solutions services through the Ambetter from WellCare of Kentucky's contractual relationships.
Why does NIA ask for a date of service when authorizing a procedure? Do providers have to obtain an authorization before the services are rendered?	During the authorization process, NIA asks where the procedure is being performed and the anticipated date of service. The exact date of service is not required. Providers should obtain authorization before scheduling the member.

Which medical providers are affected by the Medical	Any provider who orders Medical Specialty Solution Services in an outpatient setting.

Where do providers send their claims for Medical Specialty Solutions outpatient services? How can providers check	Providers should continue to send claims to the address indicated on the back of the Ambetter from WellCare of Kentucky member ID card. Providers are also encouraged to follow their normal EDI claims process. Providers should check claims status at the
claims status?	Ambetter from WellCare of Kentucky claim website at: https://ambetter.wellcareky.com/
Who should a provider contact if they want to appeal a prior authorization or claims payment denial?	In the event of a prior authorization or claims payment denial, providers may appeal the decision through Ambetter from WellCare of Kentucky. Providers should follow the instructions on their non-authorization letter or Explanation of Payment (EOP) notification.

How is medical necessity defined?	<ul> <li>NIA defines medical necessity as a service that:</li> <li>Meets generally accepted standards of medical practice; is appropriate for the symptoms, consistent with diagnosis, and otherwise in accordance with sufficient evidence and professionally recognized standards;</li> </ul>

	<ul> <li>Is appropriate to the illness or injury for which it is performed as to type of service and expected outcome;</li> <li>Is appropriate to the intensity of service and level of setting;</li> <li>Provides unique, essential, and appropriate information when used for diagnostic purposes;</li> <li>Is the lowest cost alternative that effectively addresses and treats the medical problem; and rendered for the treatment or diagnosis of an injury or illness; and</li> <li>Is not furnished primarily for the convenience of the member, the attending provider, or other provider.</li> </ul>

What will the Member ID card look like? Will the ID card have both NIA and Ambetter from WellCare of Kentucky information on it? Or will there be two cards?	The Ambetter from WellCare of Kentucky Member ID card will not contain any NIA identifying information on it.
What is an OCR Fax Coversheet?	By utilizing Optical Character Recognition (OCR) technology, NIA can automatically attach incoming clinical faxes to the appropriate case in our clinical system. We strongly recommend that ordering providers print an OCR fax coversheet from www.RadMD.com or contact NIA at 1-800-424-9230 to request an OCR fax coversheet if their authorization request is not approved on-line or during the initial phone call to NIA. NIA can fax this coversheet to the ordering provider during authorization intake or at any time during the review process. By prefacing clinical faxes to NIA with an OCR fax coversheet, the ordering provider case review.
<b>RECONSIDERATION AND APP</b>	EALS PROCESS



Is the Reconsideration process available for the outpatient Medical Specialty Solutions services once a denial is received?	Once a denial determination has been made, if the office has new or additional information to provide, a reconsideration can be initiated by uploading via RadMD or faxing (using the case specific fax cover sheet) additional clinical information to support the request. A reconsideration must be initiated within 30 calendar days from the date of denial and prior to submitting a formal appeal. NIA has a specialized clinical team focused on Medical Specialty Solutions services. Peer-to-peer discussions are offered for any request that does not meet medical necessity guidelines or can call 1-800-424-9230 to initiate the peer-to-peer process. These discussions provide an opportunity to discuss the case and collaborate on the appropriate services for the member based on the clinical information provided.
Who should a provider contact if they want to appeal a prior authorization decision?	Providers are asked to please follow the appeal instructions given on their non-authorization letter or Explanation of Benefits (EOB) notification.

request? How can I confirm what clinical information has been uploaded or faxed to NIA?	Clinical Information that has been received via upload or fax can be viewed by selecting the member on the View Request Status link from the main menu. On the bottom of the "Request Verification Detail" page, select the appropriate link for the upload or fax.
Where can providers find their case-specific communication from NIA?	Links to case-specific communication to include requests for additional information and determination letters can be found via the View Request Status link.
If I did not submit the initial authorization request, how can I view the status of a case or upload clinical documentation? Can I share my RadMD	The "Track an Authorization" feature will allow users who did not submit the original request to view the status of an authorization, as well as upload clinical information. This option is also available as a part of your main menu options using the "Search by Tracking Number" feature. A tracking number is required with this feature. Yes, through our shared access process. This
access with my coworkers?	process allows providers to view authorization requests initiated by other RadMD users within



	your practice. By sharing access with other users, the user will be able to view and manage the authorization requests that you initiated, allowing them to communicate with your patients and
	progress with treatment if you are not available.
Paperless Notification: How can I receive notifications electronically instead of paper?	NIA defaults communications including final authorization determinations to paperless/electronic. Correspondence for each case are sent to the email of the person submitting the initial authorization request.
	Users will be sent an email when determinations are made.
	<ul> <li>No PHI will be contained in the email.</li> <li>The email will contain a link that requires the user to log into RadMD to view PHI.</li> </ul>
	Providers who prefer paper communication will be given the option to opt out and receive communications via fax.
