Why is Sunflower's Kancare, Ambetter from Sunflower Health Plan, Wellcare by Allwell and Wellcare Complete (collectively known as Sunflower Health Plan) implementing an MSK Program focused on hip, knee, shoulder, and spine surgeries?	<ul> <li>The Musculoskeletal Care Management program is designed to improve quality and manage the utilization of non-emergent surgeries, occurring in outpatient and inpatient settings.</li> <li>Musculoskeletal surgeries are a leading cost of health care spending trends</li> <li>Variations in member care exist across all areas of surgery (care prior to surgery, type of surgery, surgical techniques and tools, and post-op care)</li> <li>Diagnostic imaging advancements have increased diagnoses and surgical intervention aligning with these diagnoses rather than member symptoms</li> <li>Medical device companies marketing directly to consumers</li> <li>Surgeries are occurring too soon leading to the need for additional or revision surgeries</li> </ul>
	The following procedures require prior authorization through Evolent (formerly National Imaging Associates, Inc.):  Outpatient Interventional Spine Pain Management Services:

A separate prior authorization number is required for each procedure ordered. A series of injections will not be approved.

- Spinal Epidural Injections
- Paravertebral Facet Joint Injections or Blocks
- Paravertebral Facet Joint Denervation (Radiofrequency (RF) Neurolysis)
- Sacroiliac Joint Injections
- Sympathetic Nerve Blocks

	*Surgeon must request surgery authorization for each joint, even if bilateral joint surgery is to be performed on the same date.
	Evolent does not manage prior authorization for emergency MSK surgery cases that are admitted through the emergency room or for MSK surgery procedures outside of those procedures listed.
Why did Sunflower Health Plan select Evolent to manage its MSK program for hip, knee, shoulder, and spine surgeries?	Evolent was selected to partner with us because of its clinically driven program designed to effectively manage quality and member safety, while ensuring appropriate utilization of resources for Sunflower Health Plan membership.
Which Sunflower Health Plan members will be covered under this relationship and what networks will be used?	Evolent will manage non-emergent outpatient Interventional Spine Pain Management Services outpatient and inpatient hip, knee, shoulder, and spine surgeries for Sunflower Health Plan effective April 1, 2024 through Sunflower Health Plan's contractual relationships.
IMPLEMENTATION	
What is the implementation date for this MSK program for hip, knee, shoulder, and spine surgeries?	Implementation is April 1, 2024.
PRIOR AUTHORIZATION

When is prior authorization required?	Prior authorization is required through Evolent for inpatient and outpatient non-emergent emergent hip, knee, shoulder, and spine surgeries listed.  Facility admissions do not require a separate authorization. The facility authorization will be built automatically once the procedure authorization is approved through Evolent. However, the facility should ensure that an Evolent prior authorization has been obtained prior to scheduling the surgery.
Is a prior authorization required for members who already have a musculoskeletal surgery scheduled?	Yes. Any non-emergent hip, knee, shoulder, and spine surgery performed on or after April 1, 2024 requires a prior authorization through Evolent.
Who can order a musculoskeletal surgery?	Musculoskeletal surgeries requiring medical necessity review are expected to be ordered by one of the following specialties:  Orthopedic Surgeons Neurosurgeons
Are pain management procedures included in this program?	Yes. All non-emergent outpatient Interventional Pain Management (IPM). Procedures are required to have a prior authorization through Evolent. Please refer to IPM Frequently Asked Questions.
Who will be reviewing the surgery requests and medical information provided?	As a part of the Evolent clinical review process, actively practicing, orthopedic surgeon specialists (hip, knee, and shoulder) or neurosurgeons (spine) will conduct the medical

Does the Evolent's prior authorization process change the requirements for facility-related prior authorization?	necessity reviews and determinations of musculoskeletal surgery cases.  Evolent's medical necessity re-review and determination is for the authorization of the surgeon's professional services and type of surgery being performed.
How does the ordering physician obtain a prior authorization from Evolent?	Ordering Physicians will be able to request prior authorization via the Evolent website or by calling the Evolent toll-free at:  1-877-644-4623 (Medicaid) 1-800-424-4801 (Exchange) 1-800-424-4830 (Medicare Advantage) 1-800-424-4808 (Medicare DSNP)
What information will Evolent require in order to receive prior authorization?	To expedite the process, please have the following information ready before logging on to the website or calling the Evolent call center at 1-877-644-4623 (Medicaid), 1-800-424-4801 (Exchange), 1-800-424-4830 (Medicare Advantage), and 1-800-424-4808 (Medicare DSNP) for prior authorization of nonemergent inpatient and outpatient hip, knee, shoulder, and spine surgeries:  (*denotes required information)  Name and office phone number of ordering physician*  Member name and ID number*  Requested surgery type*  CPT Codes  Name of facility where the surgery will be performed*  Anticipated date of surgery*  Details justifying the surgical procedure*:  Clinical Diagnosis*  Date of onset of back pain or symptoms /Length of time member has had episode of pain*

- Physician exam findings (including findings applicable to the requested services)
- Diagnostic imaging results
- Non-operative treatment modalities completed, date, duration of pain relief, and results (e.g., physical therapy, epidural injections, chiropractic or osteopathic manipulation, hot pads, massage, ice packs and medication)

Please be prepared to provide the following information, if requested:

- Clinical notes outlining type and onset of symptoms
- Length of time with pain/symptoms
- Non-operative care modalities to treat pain and amount of pain relief
- Physical exam findings
- Diagnostic Imaging results
- Specialist reports/evaluation

Does the ordering physician need a separate request for all spine procedures being performed during the same surgery on the same date of service?

No. Evolent will provide a list of surgery categories to choose from and the Sunflower Health Plan surgeons <u>must</u> select the most complex and invasive surgery being performed as the primary surgery.

### **Example: Lumbar Fusion**

 If the Sunflower Health Plan surgeon is planning a single level Lumbar Spine Fusion with decompression, the surgeon will select the single level fusion procedure. The surgeon does not need to request a separate authorization for the decompression procedure being performed as part of the Lumbar Fusion Surgery. This is included in the Lumbar Fusion request.

#### **Example: Laminectomy**

	If the Sunflower Health Plan surgeon is planning a     Laminectomy with a Microdiscectomy, the surgeon will select     the Lumbar decompression procedure. The surgeon does     not need to request a separate authorization for the     Microdiscectomy procedure.  If the Sunflower Health Plan surgeon is only performing a     Microdiscectomy (CPT 63030 or 63035), the surgeon should     select the Microdiscectomy only procedure.
Will the ordering physician need to enter each CPT procedure code being performed for a hip, knee, shoulder, or spine surgery?	No. Evolent will provide a list of surgery categories to choose from and the ordering physician must select the primary surgery (most invasive) being performed. There will be a summary of which CPT codes fall under each procedure category.
Are instrumentation (medical device), bone grafts, and bone marrow aspiration included as part of the spine or joint fusion authorizations?	Yes. The instrumentation (medical device), bone grafts, and bone marrow aspiration procedures commonly performed in conjunction with musculoskeletal surgeries are included in the authorization; however, the amount of instrumentation must align with the procedure authorized.
What kind of response time can an ordering physician expect for prior authorization?	Having the following information available prior to calling Evolent at 1-877-644-4623 (Medicaid), 1-800-424-4801 (Exchange), 1-800-424-4830 (Medicare Advantage), and 1-800-424-4808 (Medicare DSNP) or online through <a href="www.RadMD.com">www.RadMD.com</a> will create the most efficient turnaround time of a medically necessity decision. <ul> <li>Clinical Diagnosis</li> <li>Date of onset of back pain or symptoms /Length of time member has had episode of pain</li> <li>Physician exam findings (including findings applicable to the requested services)</li> <li>Pain/Member Symptoms</li> <li>Diagnostic imaging results</li> <li>Non-operative treatment modalities completed, date, duration of pain relief, and results (e.g., physical therapy,</li> </ul>

	epidural injections, chiropractic or osteopathic manipulation, hot pads, massage, ice packs and medication)
	Generally, within 2 to 3 business days after receipt of request with full clinical documentation, a determination will be made. In certain cases, the review process can take longer if additional clinical information is required to make a determination.
What will the Evolent authorization number look like?	The Evolent authorization number will consist of alpha-numeric characters. In some cases, the ordering surgeon may instead receive an Evolent tracking number (not the same as an authorization number) if the surgeon's authorization request is not approved at the time of initial contact. Ordering physicians will be able to use either number to track the status of their request online or through an Interactive Voice Response (IVR) telephone system.
If requesting authorization through RadMD and the request pends, what happens next?	You will receive a tracking number and Evolent will contact you to complete the process.
Can RadMD be used to request retrospective or expedited authorization request?	No, those requests will need to be called into Evolent's call center for processing at 1-877-644-4623 (Medicaid), 1-800-424-4801 (Exchange), 1-800-424-4830 (Medicare Advantage), and 1-800-424-4808 (Medicare DSNP).
How long is the prior authorization number valid?	The authorization number is valid for <u>30</u> days from the date of request for outpatient surgeries/IPM procedures, and 30 days for inpatient surgeries.
Is prior authorization necessary for lumbar, cervical, hip, knee, or shoulder surgery if	No.

Sunflower Health Plan is NOT the member's primary insurance?	
If an ordering physician obtains a prior authorization number does that guarantee payment?	An authorization number is not a guarantee of payment. Authorizations are based on medical necessity and are contingent upon eligibility and benefits. Benefits may be subject to limitations and/or qualifications and will be determined when the claim is received for processing.  Evolent's medical necessity review and determination is for the authorization of the surgeon's professional services and type of surgery being performed.
Does Evolent allow retro- authorizations?	It is important that key physicians and office staff be educated on the prior authorization requirements. Claims for hip, knee, shoulder, or spine surgeries, as outlined above that have not been properly authorized will not be reimbursed.  Physicians performing hip, knee, shoulder, or spine surgeries should not schedule or perform these surgeries without prior authorization.
What happens if I have a service scheduled for April 1, 2024?	An authorization can be obtained for all non-emergent hip, knee, shoulder, lumbar and cervical spine surgeries, occurring in outpatient and inpatient settings, for dates of service April 1, 2024 and beyond, beginning April 1, 2024. Evolent and Sunflower Health Plan will be working with the provider community on an ongoing basis to continue to educate providers that authorizations are required.

Can an ordering physician verify an authorization number online?	Yes. Ordering physicians can check the status of member authorization quickly and easily by going to the website at <a href="https://www.RadMD.com">www.RadMD.com</a> .
Will the Evolent authorization number be displayed on the Sunflower Health Plan website?	No.
What if I disagree with Evolent's determination?	In the event of a prior authorization or claims payment denial, providers may appeal the decision through Sunflower Health Plan. Providers should follow the instructions on their non-authorization letter or Explanation of Payment (EOP) notification.

Do ordering physicians have to obtain an authorization before they call to schedule an appointment?	Evolent asks where the surgery is being performed and the anticipated date of service. Ordering physicians should obtain prior authorization before scheduling the member for the surgery.

How will referring/ordering surgeons know who Evolent is?	Sunflower Health Plan will send notification letters and educational materials to plan surgeons. Sunflower Health Plan and Evolent will also conduct educational webinars prior to the implementation date for ordering physicians/surgeons.
Will ordering physician trainings be offered closer to the April 1, 2024 implementation date?	Evolent will conduct provider training sessions during prior to after April 1, 2024.
Where can an ordering physician find Evolent 's Guidelines for Clinical Use of MSK Procedures?	Evolent's Clinical Guidelines can be found on the website at <a href="www.RadMD.com">www.RadMD.com</a> . They are presented in a PDF file format that can easily be printed for future reference. Evolent 's clinical guidelines have been developed from practice experiences, literature reviews, specialty criteria sets and empirical data.
Will the Sunflower Health Plan member ID card change with the implementation of this MSK Program?	No. The Sunflower Health Plan member ID card will not contain any Evolent information on it and the member ID card will not change with the implementation of this MSK Program.

## RE-REVIEW/RECONSIDERATION AND APPEALS PROCESS

Is the re-review/
reconsideration process
available for the MSK
program once a denial is
received?

Once a denial determination has been made, if the office has new or additional information to provide, a re-review or reconsideration can be initiated by uploading via RadMD or faxing (using the case specific fax cover sheet) additional clinical information to support the request. A reconsideration (exchange plan members) must be initiated within **5 business days** (Exchange members) from the date of denial and prior to submitting a formal appeal. A re-review must be initiated within **3 business days** (Medicaid members) from the date of the denial and prior to submitting a formal appeal.

## \*\*Medicare Re-Opens are not allowed\*\*

EVOLENT has a specialized clinical team focused on IPM and MSK procedures. Peer-to-peer discussions are offered for any request that does not meet medical necessity guidelines. The MSK provider may call 1-877-644-4623 (Medicaid), 1-800-424-4801 (Exchange), 1-800-424-4830 (Medicare Advantage), and 1-800-424-4808 (Medicare DSNP) to initiate the peer-to-peer process. These discussions provide an opportunity to discuss the case and collaborate on the appropriate services for the member based on the clinical information provided.

#### RADMD ACCESS

If I currently have RadMD access, will I need to apply for additional access to initiate authorizations for MSK procedures?

If the user already has access to RadMD, RadMD will allow you to submit an authorization for any procedures managed by Evolent.

What option should I select to receive access to initiate authorizations?

Selecting "Physician's office that orders procedures" will allow you access to initiate authorizations for MSK procedures.

How can providers check the status of an authorization request?  How can I confirm what clinical information has been uploaded or faxed to Evolent?	Providers can check on the status of an authorization by using the "View Request Status" link on RadMD's main menu.  Clinical Information that has been received via upload or fax can be viewed by selecting the member on the View Request Status link from the main menu. On the bottom of the "Request Verification Detail" page, select the appropriate link for the upload or fax.
Where can providers find their case-specific communication from Evolent?	Links to case-specific communication to include requests for additional information and determination letters can be found via the View Request Status link.
If I did not submit the initial authorization request, how can I view the status of a case or upload clinical documentation?	The "Track an Authorization" feature will allow users who did not submit the original request to view the status of an authorization, as well as upload clinical information. This option is also available as a part of your main menu options using the "Search by Tracking Number" feature. A tracking number is required with this feature.
Paperless Notification:  How can I receive notifications electronically instead of paper?	Evolent defaults communications including final authorization determinations to paperless/electronic. Correspondence for each case is sent to the email of the person submitting the initial authorization request.  Users will be sent an email when determinations are made.  No PHI will be contained in the email.  The email will contain a link that requires the user to log into RadMD to view PHI.  Providers who prefer paper communication will be given the option to opt out and receive communications via fax.
