

## Maryland Physicians Care Musculoskeletal Surgery Management Program Provider Education Webinars

In keeping with our commitment of promoting continuous quality improvement for services provided to Maryland Physicians Care members, effective **October 1, 2024**, Maryland Physicians Care has entered into an agreement with Evolent (formerly National Imaging Associates, Inc.) to implement a Musculoskeletal (MSK) Surgery Management Program. This program includes prior authorization for non-emergent, **inpatient and outpatient hip, knee, shoulder, lumbar and cervical spine surgeries**. The decision to implement this program is consistent with industry-wide efforts to ensure clinically appropriate quality of care and to manage the increasing utilization of these services.
