Dear Provider,

Ambetter Health (Exchange - Iowa) has partnered with Evolent (formerly National Imaging Associates, Inc), a comprehensive Physical Medicine Quality Management Company, to implement a new prior authorization program. This program is intended to help providers effectively deliver quality patient care.

Effective January 1, 2025, rehabilitative and habilitative physical medicine services will require prior authorization through Evolent prior to being rendered in provider office, outpatient hospital/facility, or Home Health settings (planned professional services only). This prior authorization management program will apply to Ambetter Health members of all ages.

Evolent uses clinical criteria based on nationally recognized guidelines and Milliman Care Guidelines (MCG) to promote evidence-based practices. Providers may begin contacting Evolent on January 1, 2025, to seek prior authorization for services scheduled on or after January 1, 2025.

The Evolent program will apply to all specialties for the following outpatient rehabilitative and habilitative physical medicine services:

- Physical Therapy
- Occupational Therapy
- Speech Therapy

Prior authorization requests for rehabilitative and habilitative physical medicine services can be submitted to Evolent:

- Via Evolent provider portal at <u>RadMD.com</u>
- Via telephone at 1-800-642-2804. Staff is available Monday Friday from 7:00 a.m. to 7:00 p.m. CST.

RadMD offers providers the ability to:

- Request prior authorization and verify authorization status.
- Upload required clinical documentation and view submitted files.
- Access clinical guidelines, checklists and additional provider resources and tools.
- Identify the dedicated Evolent Provider Solutions Manager to use as a direct point-of-contact for any issues or questions.

Providers will need to ensure that the member's therapy benefit has not been exhausted prior to rendering services, even if an authorization has been obtained.
