| <b>What does the Evolut authorization number look like?</b>                                                       | The Evolut authorization number consists of alpha- numeric characters. In some cases, the ordering provider may receive an Evolut tracking number (not the same as an authorization number) if the provider's authorization request is not approved at the time of initial contact. Providers can use either number to track the status of their request online or through an Interactive Voice Response (IVR) telephone system. |
