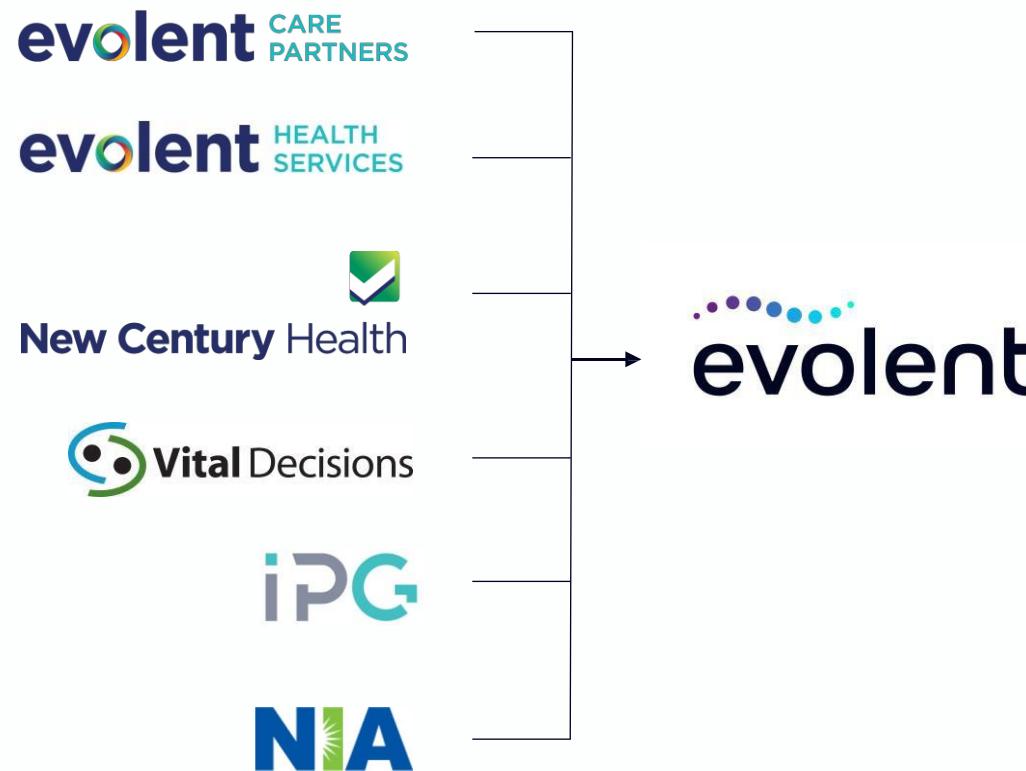

Clinical Decision Support Platform, Practice Enablement: Evolent Interventions Improve Quality at Every Step

1

Evolent RadMD platform facilitates appropriate auto authorizations at initial request submission through intuitive Q&A, auto-generated code lists, and plan preferred policy tags

2

Manual reviews to ensure authorization request meets medical necessity – request modified and subsequently approved, or escalated to Medical Directors for further review

3

Clinicians conduct practice outreach or peer-to-peer calls to discuss and agree on the best treatment plan – request withdrawn or subsequently approved

4

Denials are a last resort to address requests that do not meet appropriate evidence-based guidelines

High Level Partnership Responsibilities Across Entities

Evolent:

- Online portal for authorization requests
- Clinical guidelines and policies
- Review requests for medical necessity
 - Auto-approval of requests that meet criteria.
 - Medical necessity reviews are conducted initially by a nurse and a Clinical Reviewer (cardiologist) if needed
- Ordering provider and member notifications
- Medicaid and Ambetter appeals

Health Plan:

- Medicare appeals
- Claims management
- Case management
- Provider contracts and credentialing

Cardiology Scope of Service

Exclusions

- Clinical trials
- Emergent services
- Non-elective inpatient services
- Places of treatment and services not specifically listed as in-scope
- Services and CPT codes outside of defined scope

The following services will continue to require prior authorization through RadMD:

- CCTA
- CT/CTA
- Genetic Testing
- Hip, knee, shoulder and spine surgeries
- Interventional Pain Management (IPM)
- MRA
- MRI
- MUGA Scan
- Myocardial Perfusion Imaging (MPI)
- PET Scan
- Physical Medicine (Physical, Occupational, and Speech Therapy)
- Stress Echocardiography
- Transthoracic Echocardiogram
- Transesophageal Echocardiogram

Empowering Cardiology Clinical Team and Prior Authorization Staff to Work With Evolent

PREPARE COMPLETE, CLEAR NOTES

- Document your rationale for performing the desired service
- Clinical guidelines are available on [RadMD.com](https://www.RadMD.com)
- Include notes on any patient limitations that require use of the desired service instead of alternatives

REQUIRED CLINICAL NOTES

- Required supporting information can be attached to your request; this helps to avoid any delays in patient care, reduces the need for Evolent peer-to-peer calls, and avoids denials

EXPEDITED REQUESTS

- CMS defines an expedited request as one for which “the standard timeframe could seriously jeopardize the patient’s life or health”

FREQUENCY GUIDELINES

- Used to monitor the frequency of treatments
- Requests exceeding the frequency guidelines should include the rationale in the clinical notes
