Decisions are made as quickly as possible after submission of all requested clinical documentation. | <b>What will the Evolent authorization number look like?</b>                                                                     | <p>The Evolent authorization number consists of at least eleven alpha-numeric characters. In some cases, the ordering provider may receive an Evolent tracking number if the provider's authorization request is not approved at the time of initial contact. A tracking number is not the same as a prior authorization number. | <b>Are peer-to-peer discussions available?</b>                                                                    | <p>Peer-to-peer discussions are offered for any request that does not meet medical necessity guidelines prior to denial. These discussions provide an opportunity to discuss the case and collaborate on the appropriate services for the member based on the clinical information provided.</p> <p><b>Medicare plans:</b> Effective 8/5/2024, peer-to-peer discussions must be performed before a final determination has been made on the request.</p> <p><b>Medicare</b> re-opens are only allowed if the request complies with the CMS definition of a re-open. Providers will continue to have the option to submit an appeal utilizing the health plan's process.</p> <p>For peer-to-peer after an adverse determination has been made, follow the instructions on the denial letter.</p> |

| <b>Can I share my RadMD access with my coworkers?</b>                                                                               | <p>Yes, our shared access process allows providers to view authorization requests initiated by other RadMD users within your practice. By sharing access with other users, the user will be able to view and manage the authorization requests that you initiated, allowing them to communicate with your patients if you are not available.</p>             |
| <b>How can I receive notifications electronically instead of paper?</b>                                                             | <p>Evolent defaults communications including final authorization determinations to paperless/electronic. Correspondence for each test is sent to the email of the person submitting the initial authorization request.</p> <p>Providers who prefer paper communication will be given the option to receive communications via fax.</p>                       |
